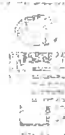

- b) You are required to execute the Power Purchase Agreement with HESCOM, Corporate Office Navanagar, P.B.Road, Hubli-580025 within 30 days (Thirty Days) from the date of receipt of this Letter of Award.
- c) In terms of the RFP and Power Purchase Agreement, you are requested to furnish the following documents within 15 days (Fifteen Days) from the date of receipt of this Letter of Award, as a pre-requisite to sign the Power Purchase Agreement.
- i. A copy of the Certificate of incorporation of the SPV
  - ii. Details of the promoters and their shareholding in the SPV, duly certified by the Company Secretary in original.
  - iii. Performance security, by the way of irrevocable bank guarantee for a total value of Rs. 30,000,000/- (Rupees Three Crores Only) in the form and manner as per the provisions of Clause 3.9 of the RFP, in favour of the Managing Director HESCOM, and shall be valid for a period of One year from COD.
  - iv. The total value of the Performance Bank Guarantee (PBG) shall be split into three Performance Bank Guarantees as detailed hereunder:
